

EXTERIOR FEATURES OF NOTE The building is a double with two entrance porches supported by square tuscan columns. Corners of main facade supported by massive brick piers and have recessed entrances. Hipped roof has a flat top, patterned slate, hip dormers and two large chimneys. The building has an ashlar foundation.		
INTERIOR FEATURES OF NOTE (DESCRIBE FLOOR PLANS, IF NOT SKETCHED) This duplex has been ordered sealed by the Nuisance Abatement Board.		
MAJOR ALTERATIONS AND ADDITIONS WITH DATES The building's exterior is apparently unaltered.
