ITEM C. EXPLANATION OF NEED FOR RENEWAL

Founded in 1919, American Farm Bureau Federation is an independent, non-governmental, voluntary organization governed by and representing farm and ranch families. As the country's largest general farm organization, Farm Bureau represents nearly 6 million member families, covering nearly every type of crop and livestock production across all 50 states and Puerto Rico. Farm Bureau is local, county, state and national in its scope and influence and is non-partisan, non-sectarian and non-secret in character. Farm Bureau is the "Voice of Agriculture" at all levels.

As has been true since the beginning of modern farming, for farmers, ranchers and rural workers the ability to repair their own mechanical equipment has been a critical need. Faced with a broken tractor in the middle of a field that needed planting tomorrow or harvesting yesterday, these individuals had no choice but to learn and to do, over and over. Their ability to do so for decades speaks to the innovative and adaptable nature of the men and women who make up the United States' farmers and ranchers.

Agricultural equipment has become increasingly technologically complex, with many vehicles now equipped with computers that monitor and control vehicle function, including basic functions such as braking. In turn, most vehicle and agricultural equipment manufacturers have adopted technological measures that restrict access to the computer software that controls these functions. Many farmers and ranchers have kept pace with the technology, and continue to repair the equipment they have purchased and which they own. Without renewal of the exemption cited above, a farmer or rancher with the desire and the ability to fix his or her equipment would be forced to wait for an 'authorized' technician, or find himself or herself in violation of the broad copyright law which prohibits 'circumvention of technological measures' employed by a copyright owner to protect their work.

Put simply, this exemption should be renewed because it should not be against the law for a farmer or rancher to fix his or her own farm or ranch equipment.
