## PORTER CHOSEN, SCHRAUB SECOND.

Named for Governor and Lieut.-Governor by State Committee.

Vote Is Unanimous for Both the Candidates, Who Stand on the Platform.

Both Chairman Danforth and William Sulzer Had Withdrawn from the Contest.

him in nomination for Governor and selected Mr. Schraub for the second place. The nominations for Governor and Lieutenant-Governor were unanimous. In each case the fifty members of the State Committee voted for the two gentlemen who had been decided upon in advance by the leaders of the party.

The ticket seems to give general satisfaction. The hand of Mr. Hill is not discernible in the choosing of either Mr. Porter or Mr. Schraub, although it was well known when the nominations were made that Senator Hill did not object to either.

Not until twenty minutes before the committee was called to order was it known who the candidate for Lieutenant-Governor would be. Only an hour before the committee met was it known that Mr. Porter would be the choice for Governor.

The matter was in uncertainty all day, owing to the desire of the leaders of the party to secure the best men obtainable. To Mr. Bryan and Tammany must be given the credit of selecting a German-American for the second place.

**Whom Hill Wanted.** There is good reason to believe that Senator Hill would have preferred Thomas Carmany, of Yates County, as the candidate for Lieutenant-Governor.

Early in the day there was a strong probability that Ellor Danforth, the chairman of the State Committee, would be decided upon for the first place. There was no specific objection on anybody's part. On personal grounds he was quite popular. Senator Hill's well-known friendship for Mr. Danforth and the latter's acknowledged fealty to the Senator, were the considerations that in the summing up made

## MR. PULITZER'S SILVER TRUST.

He Invents a "Powerful Secret and Greedy" Silver Combination.

The Latest Great Work of Fiction by the Proprietor of the New York World.

Poor Men Made Millionaires and Millionaires Further Enriched for the Purposes of This Campaign Only.

GOLD BUGS MADE INTO SILVER BUGS.

Marvelous Disregard of Facts in a Parotic Attempt to Create a Political Scare.

Mr. Joseph Pulitzer has a nose that can smell money further than most men's eyes can see it. Indeed, Mr. Pulitzer can even scent dollars where no dollars are. At present he is sniffing the fumes of an imaginary "Silver Trust," which, besides possessing almost as much money as Mr. Pulitzer would like to have, does not merely bully and coerce a President of the United States and his Secretary of the Treasury when both are in a tight place, but holds up both houses of Congress.

According to Mr. Pulitzer this "Silver Trust" also has "its directors and attorneys sit as members of the highest legislative body in the United States—the Senate—and they now dominate its committees and legislation." This tremendous "Silver Trust," the existence of which has been kept secret from everybody except Mr. Pulitzer and the World, is composed of "less than one hundred men," whose fortunes aggregate \$616,000,000, and these accumulations of their own the conspirators are, it seems, eager to cut in two by bringing about the free coinage of silver at 16 to 1, which, on the World's daily authority, will debase the currency and make the dollar worth only fifty-three cents. The commercial value of the silver product of the United States last year was, the World states, \$30,445,000, "but under free coinage"—of the success of which in raising silver billion to its coin value Mr. Pulitzer has no doubt when he is smelting the "Silver Trust"—this product "would have made a private profit to the silver plotters of exactly \$35,000,000, that being the difference between the market value and the coinage value."

Since these silver miners of the Pulitzer nostrils now own \$616,000,000 (according to the Pulitzer figures), presumably locked up in the banks, every dollar of which is a gold dollar or its equivalent, their insane desire to reduce by nearly half (according to the Pulitzer theory) the value of their stored wealth should certainly excite the interest of alienists, if not national alarm. Mr. Pulitzer will also receive the solitude of innocent alienists, for when he ventures to come down to details concerning the "Silver Trust," his reason apparently takes flight, but only apparently. Mr. Pulitzer knows what he is about, even when he permits himself to make the most preposterous misstatements of fact. J. B. Haggin, Lloyd Tevis and the Hearst estate, for example, are set down by Mr. Pulitzer as possessing together \$85,000,000. When these three were joined in interest it was chiefly in copper mines, next in gold mines, and last of all, in silver mines. And it is bad news for Mr. Pulitzer's Silver Trust.

### SEVEN WERE DROWNED.

Captain Clisby, an American, and His Companions Lost Their Lives Off Black Lead Island.

Sydney, C. B., Sept. 28.—The steamer Hope, which brought the Peary party here, brings the news of the death of Captain T. F. Clisby, in charge of the American whaling station at Signa Point, Cape Haven; Captain Hall, of the Scotch station at Black Lead Island; Mr. Parker, the missionary assistant, and four Eskimos, who were drowned off Black Lead Island August 11. They had started in a whaleboat for Salmon River, and their boat was found three days later by the missionary, Mr. Peck, partly filled with water. The body of Captain Clisby was caught under one of the thwart.

SURPRISE TO SOCIETY PEOPLE.

Bar Harbor, Me., Sept. 28.—Bar Harbor has been treated to a genuine surprise, and the Summer visitors remaining at this resort have the most delicious morsel of news to talk about that they have had for many a day. The news, which was announced late this afternoon, is that former Secretary of the Navy William C. Whitney is to be married to-morrow to Mrs. Edith Randolph.

Mr. Whitney arrived here about a week ago and was the guest of Mrs. R. H. Townsend, at Aloha. He afterward took a small cottage in Mount Desert street, belonging to the Malvern Hotel. It was reported that his object in visiting here at this time was to negotiate for the purchase of W. B. Howard's Summer residence, Mosley Hall. Nothing whatever was learned of his matrimonial intentions until to-day, and it is stated on reliable authority that the ex-Secretary himself was not sure that there was to be a wedding until yesterday.

Mrs. Randolph is an exceptionally handsome and a very charming woman. She is the daughter of the late J. F. May, of Washington, and is a sister of Fred May, who has gained some notoriety in New York and Newport. Her sisters are Mrs. C. K. Wright and Mrs. J. Beavor Webb. Mrs. Randolph has two children, a son and a daughter, aged about thirteen and fifteen. She owns a cottage here, where she entertains quite extensively. Her mother, Mrs. May, also owns a cottage here, which she is now occupying with her son and daughter, Fred May and Mrs. Wright.

The wedding will take place at 12:30 o'clock to-morrow at St. Saviour's Episcopal Church, and Rev. Christopher S. Ledingwell will officiate. It will be a very informal affair, no invitations having been issued excepting general invitations to the public. The church will be profusely decorated with laurel, white flowers, lilies of the valley and American beauty roses.
