

BRIDGE STRIKERS PLACE THE BOSS PIE.

Place a Notice of Their Own Victory on the Company's Bulletin Board. YET ALL IS HARMONY. Company Posts a Time Schedule and Invites Those Who 'Approve' to Sign It.

ALL BUT TEN HAVE DONE SO. One of the Shortest and Most Successful Strikes of Which There is Record Passes into History.

The strike of the trainmen of the Brooklyn Bridge, unique as it was from the brief time required to receive the desired concession, was made still more remarkable yesterday by the manner in which the concession was made.

Never has a strikers' victory been more complete. Never has the announcement of victory been made in so bold and unusual a manner. And the strikers numbered but one hundred and eleven men in all.

The official bulletin board of the company, on which, surrounded by all sorts of formal notices regarding men and trains, the obnoxious bulletin that caused the strike was posted, was calmly used by the men for their own notices in reply, and their own announcement of victory.

And from the tone of these notices from the men one would never suspect that they were written by employees in fear of discharge from their positions. They read, instead, like announcements from men in a position to treat on equal terms.

'You are requested to designate your approval or disapproval of the proposed new list of rates.' That is a simple sentence, and it points to a remarkable spirit and to a remarkable state of affairs.

'That is a sample sentence, and it points to a remarkable spirit and to a remarkable state of affairs. The men of the motor and conductors who operate the Bridge trains have held their positions for ten to eighteen years.'

'It was a sad change for them. They were well paid and well treated by the city, but when, a few months ago, the city turned over the Bridge trains to the Brooklyn Elevated Railroad, oversight of the men was completely given up. And Deputy Bridge Commissioner York, who was seen yesterday, said:

'We could not interfere if the company paid only ten cents a day to the men, who have served the city faithfully for many years.'

With no possible hope of assistance from the city the little band of strikers prepared to stand for their rights.

On February 27 a bulletin was posted regarding the wages of some of the men and fantastically changing the hours of all. So indignant were the men that a strike was at once threatened. The manager learned of this and withdrew the clause regarding reduced pay.

But so extreme were the changes in the time schedule that the men struck for that alone. This was last Tuesday morning, and within twenty minutes the company had agreed to withdraw the objectionable schedule.

Then began a remarkable series of events. The men tore down the obnoxious bulletin and in its place the next day in the very center of the official bulletin board, was put up a triumphant notice, signed by the committee, declaring that even the old schedule under which the men had been working for months was to be improved, and that a new one was to be posted and 'approved by the men.'

This was signed by the committee. It was an interesting sight throughout the day to see the men walk into the room from their trains, read the proposed schedule and sign their names. By far the majority of the schedule received that all but ten men signed for approval.

Motor men are to continue to receive \$2.25 a day and conductors \$2. Most of the men are to work on straight shifts of ten hours each, with time allowed for lunch. Some are to work on two 'average' days, with several hours between the 'average' days, and making only eight hours of work. But it is arranged that month in and month out the men will rotate, so as to give all a turn at the most favorable hours.

And thus ends a strike remarkable for the sober and unexcited way in which it was conducted, and remarkable for the circumstances of its conclusion.

JUSTICE BEACH CRITICISES GOFF. He Declares the Recorder's Treatment of an Accused Man Was 'Very Harsh.'

George Cahill, whose recognition was declined valid by Recorder Goff a week ago, because of his non-appearance when called on to plead to an indictment for grand larceny in the Court of General Sessions, was brought before Justice Beach, in the Supreme Court, yesterday, for the purpose of having his bail reduced.

A SURE 100 TO SHOT. WATCH FOR THE NUMBER. If You Have the Missing Bill You Will Get \$100. HOLD YOUR DOLLAR BILLS. This Sum Will Be Paid for It Tomorrow.

Perhaps among your dollar bills there is one that is worth \$100. Of course, you have heard that there is a big reward out for a certain greenback which escaped from a man recently. Its face value calls for but \$1, but that does not alter the fact that the reward is \$100.

But where is it now? Somewhere around New York, surely, and it is safe to say that one man of the million or two who reads this story actually has it on his person.

It is just like finding money on the breakfast table if the much-sought-after bill should happen to be among your greenbacks. Really, there is an opportunity before you now that should not be slighted. It requires very little labor to scan your money. Put your hand right into your pocket, take out your wallet and spread the money before you.

What do you see? One, two, three, four, perhaps more. But you have at least one dollar bill. Look at the number. What is it? Well, there you are again. You don't know what the missing bill contains in numbers. But you shall know, and know to-morrow. The Journal will give the exact number wanted. Do you see the point? Certainly. One of those bills you looked at the day before may be the key to the greatest mystery in the history of the money market.

It must be obvious to you now that it is worth your while to get all the dollar bills you can between now and to-morrow morning.

How many things can you purchase with \$100? Is there one man in a million who would not like to get his hands on that amount to do with as he chooses? It's yours if you find the bill. But you are beset with dangers, that is to say, the dangers of letting the bill get away from you after it has drifted your way. To-morrow morning, among the 'Want ads,' the number will be printed for the first time, and you can then go over your reserve stock of greenbacks and find out where you stand. It will be fascinating if you have plenty of dollar bills to keep you engaged for a while.

Another great comfort to you will be the knowledge that even though you have not the right number, you have stacked up a very fine nest egg during the week. Who knows but what this accumulation of \$1 bills may be the foundation of a great fortune that may some day manipulate the Manhattan stock, corner the pork market, shake up the wheat barons, stun the markets of Great Britain and send Wall Street a-wooing? There is no limit to the power of money. It is the most fascinating, absorbing passion one can gratify.

But the act of picking up \$100 just because one has a certain dollar bill in his possession is a novelty that is not plentiful, even in Washington, where the national surplus holds forth.

Now that you have read this budget of good advice, the rest is left for you. There are about twenty-four hours left in which you can hustle around and get hold of dollar bills. MRS. WILMERDING HAD A CHANGE OF MIND. Astonished Her Lawyer by Requesting That Her Guardians of Person and Property Be Not Discharged.

Mrs. Jack Wilmerding, granddaughter of Commodore Vanderbilt, lately released from Bloomingdale Asylum, exercised the inalienable right of a woman to change her mind yesterday before Judge Gildersleeve in Part I of the civil-branch of the Supreme Court.

The committee consisted of her two uncles, Franklin Allen and John Wallace. The committee's counsel is John B. Gleason.

Her personal counsel was much surprised the other day when she learned that Mrs. Wilmerding had switched over to the committee. The peculiarity of her action suggested that she might have become mentally perturbed. Justice Gildersleeve therefore requested that she personally appear before him and declare her wishes.

The lawyers were inclined to quarrel, when Justice Gildersleeve decided that he would consider memorandum orders from both the committee and Mr. Levy next week.
