

BRYAN CHEERS SILVER'S FORCES. Bimetallism, He Says, Has Not Been Vanquished, but Only Overcome.

Its Friends Will Continue to Fight Gold Until Convicted of Error.

In Spite of Tremendous Opposing Influences, He Declares, Silver Almost Triumphed.

AMPLY REPAID FOR HIS EFFORTS.

He Expresses His Wife's and His Own Appreciation of the Devotion of Their Friends—National Committees Thanked.

Lincoln, Neb., Nov. 6.—Mr. Bryan to-day issued the following statement:

To the Bimetallists of this Country: Consider that millions of loyal hearts are saddened by temporary defeat, I beg to offer a word of hope and encouragement.

They have fought from conviction, and have fought with all the zeal which conviction inspires. Events will prove whether they are right or wrong.

Bimetallists Not Conquered. The Republican candidate has been heralded as the advance agent of prosperity.

The friends of bimetallism have been simply being vanquished. They believe that the gold standard is a conspiracy of the money-changers against the welfare of the human race.

The contest has been waged this year under great embarrassments and against great odds. For the first time during this generation public attention has been centered upon the money question as the paramount issue.

The Republican Convention held out the delusive hope of international bimetallism, while Republican leaders lusted secretly for gold monometallism.

Gold standard Democrats have publicly advocated the election of the Indianapolis ticket while they labor secretly for the election of the Bryan ticket.

Almost a Truce. The trusts and money interests have been the ablest and most successful of the nation's financial independence.

But in spite of the efforts of the Administration and its supporters; in spite of the threats of money-lenders at home and abroad; in spite of the coercion practised by corporations and employers; in spite of trusts and syndicates; in spite of an enormous Republican campaign fund; and in spite of the influence of a hostile daily press bimetallism has almost triumphed in its first great fight.

The loss of a few States, notwithstanding, has by a very small plurality, but defeated bimetallism for the present, but bimetallism emerges from the contest stronger than it was four months ago.

I desire to commend the work of the three National Committees which have labored in the management of this campaign. Cooperation between the members of distinct political organizations is always difficult, but it has been less so this year than usual.

No Grief for Defeat. I hereby express my personal gratitude to the individual members as well as to the executive officers of the National Committee of the Democratic, Populist and silver parties for their efficient, untiring and unselfish labors.

No personal or political friend need grieve because of my defeat. My ambition has been to secure immediate legislation rather than to enjoy the honors of office.

Therefore defeat brings to me no feeling of personal loss. Spending for the wife who has shared my labors, as well as for myself, I desire to say that we have been amply repaid for all that we have done.

In the love of millions of our fellow-citizens, so kindly expressed in knowledge gained by personal contact with the people, and in benevolent sympathies, we find full compensation for whatever efforts we have put forth.

In the face of an enemy relying in its victory, but the call is still for the engagement, and urge all friends of bimetallism to renew their allegiance to the cause.

Theories to Be Tested. Our opponents have succeeded in their campaign and must now put their theories to the test.

The year 1896 is not far away. Before that year arrives, international bimetallism will come to decision; before that year arrives those who have called themselves gold standard Democrats will become bimetallists and be with us, or they will become Republic

and thus open enemies; before that year arrives trusts will have convinced still more people that a trust is a menace to private welfare and to public safety; before that year arrives the evils of a gold standard will be even more evident than they are now, and the people then be ready to demand an American financial policy for the American people, and will join with us in the immediate restoration of the free and unlimited coinage of gold and silver at the present legal ratio of 16 to 1 without waiting for the aid and consent of any other nation.


