TOADSTOOL VICTIMS IN A SINGLE GRAVE.

Henry Goldbach, His Wife and Son Buried at Trenton—Four Others Likely to Die.

The three members of the Goldbach family, of Trenton, who died after a feast of toadstools, which were supposed to be mushrooms, were buried in one grave yesterday afternoon. They were the father, mother and son, Charles.

Two black berries and a white one carried to the Jewish cemetery. They were followed by a long line of mourning friends and relatives, and were watched by a great crowd of the curious.

The four others who partook of the deadly vegetable are in a precarious condition and there is little hope of their recovery. Henry Goldbach was a grocer. He bought three pounds of what he supposed were mushrooms from Hermann Gebhart on Saturday afternoon intending them for his Sunday dinner. Gebhart had gathered them when he was out in the woods that morning, and he had dropped into the grocery store on his way home, saying he was going to make a present of the mushrooms to some friends of his.

The father-in-law, who is past sixty, was the first to feel the effects of the deadly food. He was seized with nausea about 5:30 in the afternoon, but as he was subject to such attacks he did not attribute to the evening's meal until 11 o'clock that night Henry Goldbach succumbed, and soon after the rest of the family became very ill. Max Goldbach, Henry's brother, though he was present at the table, had not eaten any of the toadstool.

STOCK TRADING DULL AND HEAVY

Late Erie & Western, by Its Rapid Changes, Afforded the Only Feature of Market.

Wall Street, Oct. 19. Trading in stocks was almost at a standstill today. At the opening, prices were depressed by a lower market in London and the liberal offering of stocks here by arbitrage brokers.

There was no special feature in the trading except the startling fluctuation in Lake Erie & Western preferred, which has been steadily pounded. Fears that the dividend would be passed, caused a break in the stock of 6 points from the opening, to 53.

Subsequently, when the directors declared the regular quarterly dividend of 1 1/4 per cent, the price jumped up 10 points, to 63, and closed with a net gain of 1 1/4, at 62. Delaware, Lackawanna & Western sold for 140, which is 8 1/4 points under the last previous sale made several days ago.

Money was easy, exports of grain and mechanical and other goods, and early shipments coming to hand extremely favorable. Export sales of wheat alone were estimated at 1,500,000 bushels, the largest of the single day during the present season.



THE SHEAR TRUST IS THE VERY LATEST.

Big Organization to Control the Output of Cloth Cutters. CAPITALIZED AT \$3,000,000.

Will Shut Down Half of the Shear-Making Plants in America.

A new trust has quietly taken its place in the arena of organized capital within the past week. It is styled "The National Shear Company," and it has begun doing business from general offices at No. 290 Broadway.

It has purchased outright or controls by options not yet expired five-sixths of the annual output of existing factories in the United States. Under its Jersey charter \$3,000,000 in stock has been issued and subscribed, \$1,250,000 preferred, \$1,750,000 common.

The new trust was organized by J. H. Claus, a young man, of Fremont, Ohio. He began life as a poor boy in the little town, and has built up a great industry, his shear factory being one of the largest of those taken over by the trust. He is the president of the new company.

The other officers are: F. C. J. Wiss, of Newark, N. J., vice-president; O. H. Story, of Boston, secretary; H. Claus, of Fremont, Ohio, treasurer.

"It is not the intention of the National Shear Company to raise prices," said Mr. Claus yesterday. "The only object of our organization is to save money at every point in the process of manufacture and distribution. There are thirteen or fourteen shear manufacturers in the United States. Most of them have been shut down half the time, or have been running at a loss during the past two years."

"American manufacturers make the best shears in the world, but we are so hard pressed by German competition right here in our own market that we are obliged to sell on a very close margin of profit. We could not raise the prices if we wanted to, for it would only mean increased importation from Germany. The consolidation will not throw many men out of employment, nor will it reduce wages. There are only 1,200 to 1,500 shear makers in the United States, all told."

THE CORONER INVESTIGATES.

Coroner Dishrow, of Trenton, and Conny Physician Rogers made an investigation on Tuesday evening and decided that the three deaths were the result of unintentional poisoning. They gave permits for the burial of the dead.

Hermann Gebhart, who sold the mushrooms, had taken his three pounds, Gebhart presented to Christopher Walters, of Hamcock avenue and Cass street. Walters put them aside over night, and next day when about to redden them, he noticed a peculiar reddish exudate upon them and decided to throw them away. It was a mere chance that saved two others from becoming victims of Gebhart's fatal mistake.

John Drabb, an employee, had been asked to dinner by Goldbach, and refused because it was late, and he wanted time to fill another engagement. A cousin of the dead man named Michelson was in the habit of dining every Sunday night at the Goldbachs, but stayed away on this particular occasion because of the sudden illness of his wife.

The varieties of mushrooms are so nearly alike that it is almost impossible to distinguish the edible from the deadly poisonous. The tests that are popularly supposed to make known the toadstool's presence, such as holding a silver spoon in the pot and noting whether it turns black, are now said to be ineffectual. The recently discovered antidote, atropine, is supposed to have had no effect. The poison of the most deadly variety of toadstool is the slowest in making itself felt in the system.

The minor poison begins to work within four or five hours after the fungus has been eaten. If it is ten or twelve hours before the symptoms develop the deadly principle, amantine, is evidently present and the cure is almost always hopeless.
